# Access to Justice for Victims of Human Rights Abuses by Transnational Corporations

Tuesday, October 27, 2015 - 1 – 7 PM

Berlin, Friedrich-Ebert-Stiftung, Hiroshimastraße 17

Corporations have the responsibility to honor human rights – they should take appropriate measures to recognize human rights violations, prevent them, and potentially rectify and remedy them. For that purpose, it does not matter in which country an injustice occurs because those affected should have access to justice everywhere.

Operations by transnational corporations (TCs) cause human rights violations worldwide. While trade and investment contracts provide corporations with extensive rights for their operations, victims of their human rights abuses do not have effective access to binding legal processes.

Corporate responsibility is based on voluntary remedy and complaint mechanisms. However, it will often constitute a comparative disadvantage for corporations to observe human rights standards voluntarily – especially when the competition does not.

Therefore, governments must prescribe due diligence obligations by law so that they are legally enforceable by those affected. The German government too should spring into action and allow redress for victims that have suffered human rights abuses through the actions of German corporations abroad.

Together with guests from the Philippines and Colombia, we want to scrutinise different pathways to justice and remedies for victims. This will also include the discussion of various processes on the UN-level, as well as the introduction of a German criminal law for corporations.

The conference will take place in German, Spanish and English. Simultaneous interpretation will be provided for.

The session is organized by FDCL e.V., philippinenbüro e.V. im Asienhaus and the Friedrich-Ebert-Foundation and will take place in the course of the 2nd Alternative Resource Week from the 19th to the 27th of October.
